INSTRUCTIONS FOR AUTHORS

The Comunicata Scientiae journal edited by Campus "Profa Cinobelina Elvas" of Federal University of Piauí (Brazil) publishes original articles, scientific notes and review articles (when invited by the editorial board), which present significant importance for Agrarian and Environmental Sciences in Portuguese, Spanish and **preferentially**, in English.

All manuscripts should be on line submitted in electronic address

(http://www.ufpi.br/comunicata),

All manuscripts must be sent in paper size A4 (210 x 297mm), with pages and lines consecutively numbered, double spaced, using font Century Gothic 12 and all margins of 2 cm. The manuscript length is limited to 30 pages for original articles and 10 pages for scientific notes, including tables, figures and illustrations, which should come positioned immediately below its first citation in the text and it must have brief explanatory captions. For animal experimentation it must contain the research approval by the Local Ethics Committee attached as a supplementary document

After it receipt, the manuscript will be evaluated previously by a scientific editor of the area and then sent to at least two scientific referees (ad hoc) independent and competently recognized in the subject area of the manuscript whose evaluation will follow pre-established guidelines (Annex I) and constrain its publication. Original articles should contain the following sections: Title; Abstract; Key words; Introduction; Material and Methods; Results and Discussion (separate sections are also accepted); Conclusion; and References. The keywords should be a maximum of five (5) must not be contained in the title and should reflect the central idea of the manuscript.

Acknowledgment(s) when relevant, should be included before the references, this topic can indicate the funding of research and other types of collaboration that helped its development.

Scientific notes should contain: Title; Abstract; Keywords and References.

The topics should be in bold, sub-topics italic, both aligned to the left and only the first letter capitalized.

The file extension of the work ".doc" or ".docx" shall not contain the names of the authors, these should be included in the submission process on

your third step "Enter Metadata" with the following required information: full name, e-mail, institution/affiliation (city, state and country) of a maximum of six (6) authors. More than six authors are accepted upon justification only.

Papers based on limited routine experiments will not normally be considered for publication.

In the text, references should be cited by author and year, e.g. "(Henze, 2006)", "(Henze & Brown, 2006)", "(Henze et al., 2006)", "... as reported by Henze et al. (2006)". References should be listed in alphabetical order and following the examples below:

Authors should cite, preferentially, articles from journals indexed in ISI Web of Knowledge, Scopus or Scielo, avoiding proceeding papers and dissertation/thesis. In addition, citations of personal communication or articles "in press" are not allowed.

Tables and Figures must be self-explanatory, with characters in font Century Gothic 10, numbered consecutively with Arabic Numerals Titles should appear below tables and above figures, respectively inserted after your calls with the title below to figures and tables up to. Figures should not present borders. Photographs and color illustrations may be sent..Example title formatting of tables and figures: Table 1. Mean percentage of normal seedlings(germination) at 45 days of seeds of nine varietiesof citrus subjected to priming.

After you final acceptance of the work, the authors will be requested to submit figures on individual files, up to 300 dpi with one of the following extensions (tif, jpg or bmp), with a maximum size of 1Mb per file.

The scientific nomenclature shall be cited according to the criteria laid down in the International Codes of each area.

Units and Measurements should follow the International System (SI).

The journal takes a Creative Commons license, reserving the right to make, in original, normative changes, spelling and grammar, in order to maintain the standard language of worship, respecting, however, the authors' style. The finals will be sent to authors.

One time published work may be transcribed, partially or totally, by the citation of Comunicata Scientiae, author, volume, pagination and year. The opinions and concepts expressed in the articles are the sole responsibility of the author.

In the act of submission of the required statement authors confirm absence of conflict of interest as a condition of submission.

There is no charge for submission or publication.

Manuscript out of journal's scope
Manuscript presentation not in agreement with the instructions for authors
The title is not informative and relevant to the contents of the manuscript
The abstract is not clear and concise. It doesn't fully summarizes the contents of the manuscript
The introduction not clearly outlines the problem
The introduction is not adequate and it not well states the objective
The experiment (s) is (are) not properly planed and checked
The materials and methods are not appropriate to this specific topic and are not the most
advanced techniques used
The results of the study are not scientifically novel
There are few citations of articles
Most of references are not actual (50% or less from the last 10 years)
Statistical analyses used are not valid or not enough
The discussion is not relevant to the experimental results obtained in the study
The results are not discussed in the light of previous published results in its specific field
There are too many or too few figures or tables
Tables or Figures with no satisfactory quality
There are data presented twice
There are no sufficient results to justify the conclusions
The conclusions are not related to the manuscript objective
The references are not correct
The English is poor and it could be improved
